**PLEA / RESPONSE CODES – FINDING AND JUDGMENT CODES:**

**Infraction Issue Plea/Response – Non-Civil**

- C**            **Committed**  
Defendant asserts he/she has committed the infraction as charged.
- NC**           **Not Committed**  
Defendant asserts he/she has not committed the infraction as charged.

**Criminal Issued Plea / Response – Non-Civil**

- NG**           **Not Guilty**  
Defendant pleads not guilty to the charge.
- G**             **Guilty**  
Defendant pleads guilty to the charge.

**Infractions Finding / Judgment Types – Non-Civil**

- AM**           **Amended**  
Original infraction has been amended to a different charge.
- AS**           **Awaiting Sentence**  
Defendant found to have committed the infraction charged and now awaits sentencing by the court.
- C**             **Committed**  
Defendant found to have committed the infraction charged.
- CV**           **Change of Venue**  
Infraction transferred to the court in the appropriate geographical area pursuant to IRLJ2.3.
- D**             **Dismissed**  
Infraction dismissed (use appropriate dismissal reason code).
- DO**           **Dismissed without Prejudice**  
Infraction dismissed without Prejudice (use appropriate dismissal reason code).
- DP**           **Deferred Prosecution**  
Petition for deferred prosecution granted for infraction charged pursuant to RCW 10.05.010.

- DS**            **Deferred Prosecution**  
Defendant found to have committed an infraction, conditions imposed and now awaits sentencing on final outcome pursuant to RCW 3.66.067.
- DW**            **Dismissed with Prejudice**  
Infraction dismissed with prejudice (use appropriate dismissal code).
- NC**            **Not Committed**  
Defendant found not to have committed the infraction charged.
- OD**            **Other Deferral / Diversion**  
Where the court orders or allows the parties to enter into a stipulated agreement, which imposes specific conditions on the defendant. Upon completion or adherence to the conditions the court may dismiss the charge, amend the charge, or the defendant may enter a response of not committed. This is known as a deferred finding, deferred sentence, agreed continuance, or court accepted diversion program.
- P**              **Paid**  
Defendant found to have committed the infraction charged, pays the penalty in full and does not contest the charge nor ask for a hearing to explain the circumstances.

#### **Criminal Finding / Judgment Types – Non-Civil**

- AM**            **Amended**  
Original offense charged has been amended to a different charge.
- AS**            **Awaiting Sentence**  
Defendant found guilty of the offense charged and now awaits sentencing by the court.
- BF**            **Bail Forfeiture**  
Defendant allowed to forfeit bail and is found guilty of the offense charged pursuant to CrRLJ3.2(m).
- BO**            **Bound Over**  
Court finds probable cause exists to believe the accused committed the offense charged and binds the charge over to superior court pursuant to CrRLJ3.2.1.
- CV**            **Change of Venue**  
Offense transferred to the court in the appropriate geographical area pursuant to CrRLJ 5.2.

<b>D</b>	<b>Dismissed</b> Offense dismissed
<b>DO</b>	<b>Dismissed without Prejudice</b> Offense dismissed without prejudice
<b>DP</b>	<b>Deferred Prosecution</b> Petition for deferred prosecution granted for offense charged pursuant to RCW 10.05.010.
<b>DW</b>	<b>Dismissed with Prejudice</b> Offense dismissed with prejudice
<b>G</b>	<b>Guilty</b> Defendant plead or found guilty of the offense charged.
<b>GD</b>	<b>Guilty Deferred Pros. Revoked</b> Defendant found guilty of the offense after other deferral / diversion program was revoked or program completed and the defendant plead guilty to amended or reduced charge.
<b>GO</b>	<b>Guilty Other Deferral Revoked / Reduced</b> Defendant found guilty of the offense after other deferral / diversion program was revoked or program completed and the defendant plead guilty to amended or reduced charge.
<b>NG</b>	<b>Not Guilty</b> Defendant found not guilty.
<b>OD</b>	<b>Other Deferral / Diversion</b> Where the court orders or allows the parties to enter into a stipulated agreement, which imposes specific conditions on the defendant. Upon completion or adherence to the conditions the court may dismiss the charge, reduce the charge to a lesser offense, or the defendant may enter a plea of not guilty. This is known as a deferred finding, deferred sentence, agreed continuance, or court accepted diversion program.
